

Kumi in bōk eddoon ro im e jab mālem aer jerbal ak lelok kapilik āinwōt juon lawyer

FAQ (kajjitōk ko im ekkā wōt an armej kajjitōk kaki)

**Q. Ta in “practice in law,” āinwōt ba,
kōmmanni jerbal ko an juon laywer ilo
Arkansas?**

A. Ejjelok juon wōt melele kin “practice of law” me e lukkuun jejjet. Bōtab Arkansas Supreme Court, kōn an bōk kunaan ilo elōñ case ko, ear pepe im kakien bwe men kein ilal rej mōttan melele ko kin “practice of law.”

Ñe juon armej ej walok imaan juon Court of Record bwe en kamadmōdi jabdewōt men ikijjen juon case me e jañin mōj aer kōmman pepe kake, ak ñe juon armej ej pukot bwe en kajerbal jabdewōt manit ak makutkut an Court ikijjen jabdewōt men me ej pād iumwin tōl im pepe an Court, innām armej eo ej kōmmane “practice of law.” Ñe juon armej ej kōmman jabdewōt jerbal me ej āinwōt jerbal in legal (āinwōt ba, kain jerbal eo me juon lawyer en kōmmane) me ejab bōk jikin ilo juon courthouse (ak iumwin maroñ eo an Court), im e jab ikijjen jabdewōt case me ej bōk jikin ilo Court me e jañin jemlok, innām ej kōmmane “practice of law.” Ñe juon armej ej kōmmane juon bujen in lelok mweiuk jān juon armej ñan bar juon armej, ñe ej kapooje jabdewōt kain peba ak record me ej legal, ñe ej kapiloklok juon armej, im ñe ej pinej jenkwaer ilo jabdewōt men ekkar ñan kien, innām ej kōmmane Practice of Law.

**Q. Wōn eo im ewor an maroñ
bwe en kōmmanni jerbal ko an
juon lawyer?**

A. Lawyer eo wōt me ewor an mālim in jerbal ilo Arkansas e maroñ kōmmani jerbal ko an lawyer ilo State jab in. Juon lawyer emaroñ bōk mālim in kōn an bōk juon an license jān State in Arkansas. Barāinwōt, ñe State in Arkansas ej kōtlok bwe en jerbal iumwin Pro hac Vice (melele in ej bwe juon lawyer me ejjelok an license ilo juon State e maron jerbal ilo juon case ñe ej kajjitōk mālim, im State eo ej ba, “Emman”). Baj lale Rule 5.5 an Arkansas Rules of Professional Conduct. Ijoke, Arkansas Supreme Court Administrative Order No. 15 ej kōtlok bwe juon lawyer me ejjelok an license ilo Arkansas e maroñ in jerbal pro bono (free, ejjelok onean) im ej jerbal iumwin tel im pepe an juon Legal Aid Provider me ej sponsor e.

**Q. Wōn eo im e jab mālim an jerbal
āinwōt juon lawyer ilo Arkansas**

A. Elōñ armej rej lōmnak bwe ro im rej kōmmani jet kain jerbal ko, ewor aer maroñ bwe ren jerbal āinwōt juon lawyer im bwe re maroñ lelok kapilok ilo jet wāween ko. Ijoke, e jab mool men in. Lale jet waanjoñak ko ilal:

Paralegals

(Juon eo me emōj an jikuul in kien. Ej jerbal iumwin peen juon lawyer ak ejjelok an license in lawyer)

Juon paralegal e jab maroñ jerbal āinwōt juon lawyer. Ro im rej jerbal in Paralegal re maroñ bōk kunaaer wōt ñe juon lawyer me elōñ an license in Arkansas ej pād ioeir im lale er.

Law Students

(Ri jikuul in lawyer)

Enañin aolep iien ri jikuul in lawyer re jab maroñ lukkuun kōmmani jerbal in lawyer. Bōtab, jet re maroñ in jojomaare juon armej ñe rej kajejjete Rule XV (15) an Arkansas Supreme Court Rules Governing Admission to the Bar (Rule ko me rej kamālim juon lawyer bwe en jerbal ilo State in Arkansas). Barāinwōt lale Rule 46B an Rule ko an Eighth Circuit Court of Appeals. Ej melele in bwe juon lawyer me elōñ an license jan Arkansas en jutak iliken im lale ri jikuul in kien eo.

Suspended or Disbarred Lawyers

Lawyer ro me emōj dāpij license eo aer ak jolok e re jab maroñ in jerbal. Im elōñ jerbal ko jet in lawyer e mo aer kōmmani. Lale mōk Rule 22 ilo Arkansas Supreme Court Procedures Regulating Professional of Attorneys at Law (Jemānae ko an Arkansas Court eo Elap ñan lale mantin jerbal ko an Lawyer)

Real estate brokers, title insurers, abstractors and bankers

*(Ri wia kōn em im bwidej [Real Estate], Ri insure
contract, ri pukot im kojparok record ko an real estate
[abstractors], im ri jerbal in Bank).*

Ñe juon armej e makoko in bōk juon an lawyer, juon real estate broker e maroñ in kanne juon paper in real estate me emōj an juon lukkuun lawyer kamālim e. Peba kein re ban jerbal ñan jabdewōt bar juon men ijelloken wōt ñan wia juon em ak bwidej. Im renaaj jerbal wōt ñan bujen ko (transactions) me emōj an real estate broker make kōmmani im ejjelok onean.

Kien ko me rej jelōt real estate broker rej barāinwōt jelōt title insurer ro im bar abstractor ro.

Meñe Arkansas Court e jañin kōmmane juon case me ear lukkuun kōnono kake jerbal ko an bank ko ilo aer kanne peba ko me emōj an lawyer ro kamālimi, jej melele bwe kien ko ikijjien real estate brokers rej ejja kien ko wōt im re jelōt bank ko im mortgage company ko.

Notaries

*(Juon eo me ewor an maroñ ñan kamooli
eltan peen armej im peba ko re aurōk).*

Ewor an notary maroñ ñan wõt kamool imaan mejän juon ri jerbal in kien bwe eltan peen juon armej ilo juon peba ejejjet im jimwe. E mo aer bõk oneän kõn aer kapooji peba ko an kien (legal documents).

Notorios (ro im rej notary public ilo lal ko jet) ak ro im rej lelok kapilek ñan ro im rej deloñ diwõj Amedka (Immigration Consultant) e mo aer lelok jabdewõt kain kapilek kõn Court (legal advice) ikijjen an armej deloñ ilo Amedika (immigration). Lawyer ro me ewor aer license im ri pinej jenkwani armej me rej accredited (emõj kamaroñ er) me United States Board of Immigration Appeal ej kile er wõt re maroñ in lelok kapilek kõn an armej deloñ diwõj Amedka (immigration).

Q. Lawyer ro me re jab jokwe ilo Arkansas, re maroñ ke jerbal ilo court ko an Arkansas?

A. Lawyer ro me re jab mour im jerbal ilo Arkansas re maroñ jojomaare armej elaññe rej bõk juon aer license jän Arkansas ak elaññe rej jerbal iumwin Pro hac Vice (melele in bwe juon lawyer me ejjelok an license ilo State eo im case ej bõk jikin ie, e maron jerbal ilo case eo ñe ej kajjitõk mälim im State eo ej ba, “Emman”). Baj lale Rule 5.5 an Arkansas Rules of Professional Conduct. Elaññe juon lawyer jän bar juon State e kõnaan jerbal pro bono (free, ejjelok onean), Arkansas Supreme Court Administrative Order No. 15 ej kõtlok bwe en jerbal.

Q. I maroñ ke jojomaare eõ make (represent) ilo juon case?

A. Aaet. Juon armej e maroñ in jojomaar ñan e make (represent e make, juon lawyer ñan e make) ilo juon case. Bõtab, armej in e jab maroñ in jojomari armej ro jet, business ko, ak legal entity (ainwõt LLC); ainwõt juon ñe kwoj owner eo wõt.

Q. Elaññe ña ij aõ make lawyer, ewor ke jet peba ko (forms) me I maroñ kajerbal ñan jipañ eõ kõn case eo ao?

A. Aaet. Kwon etal ñan ([LINK](#)) online bwe kwon maroñ in lale peba in kõmmelele ko (legal forms). Peba kein rej kajerbal kajjitõk im uwaak ñan jipañ yuk kanne kajjojo form kõn melele ko re aorõk ikijjen jet pãdpãd ko ñan kõmmane

juon case. Im form in enaaj make kõmman juon peba ekkar ñan wāween am uwaak kajjitōk ko. Ewor kõmmelele ippān kajjojo form im e aorōk bwe kwon lukkuun in ready im loore.

Q. I maroñ ke jojomaare uwaan baamle e aõ ilo juon case?

A. Jaab. Meñe juon eo me ejab lawyer emaroñ jojomaare uwaan baamle eo an ilo jet kain case etan Administrative proceedings (juon pepe ñan na ruon juon armej me ej walok tulōkin Court), e jab maroñ jojomaare uwaan baamle eo an ilo juon lukkuun case in Court. Im elaññe ej akwelap kõn administrative proceeding eo ñan juon Court in kien, e jab maroñ in jojomaare uwaan baamle eo ilo case jab in.

Q. I maroñ ke jeje im lelok juon kajjitōk ñan Court (file a petition) ikijjen aõ bõk eddoon (lale) ajri im rütto, ak kajjitōk ko ñan kamooli peba in jolõt (probate wills) im walok ilo juon mõn ekajet (Court) ãinwõt ri lale (bõk eddoon) im kõjparok bar juon armej (guardian), ak eo im ej lale men ko mweien bar juon armej me emõj an Court kamoole (probate estate)?

Jet court rej kõtlok bwe juon eo me ejab lawyer e maroñ jeje juon kajjitōk (file a petition) bwe en ri lale ajri ak rutto, ak jet re ban. Arkansas Supreme Court e jañin kõmman juon pepe kõn men in. Kwon lale “In re Pro Se Filings in Estate and Guardianships in the Washington County Circuit Court, 2015.”

Ilo case eo etan Arkansas Bar Association vs. Union National Bank, 224 Ark. 48, 51-52, 273 S.W. 2d 408,410 (1954), Arkansas Supreme Court ear pepe bwe “juon armej me ejjelok an license in lawyer im ej jerbal ãinwõt juon ri loloorjake, executor, ak juon ri lale armej, e jab maroñ jerbal ãinwõt juon lawyer ikijjen men ko me rej mõttan men ko im rej pãd iumwin peen (trusteeship) meñe ej lõmnak bwe ej jojomaar ñan e make.”

Ñe emõj kile juon eo me e jab lawyer bwe en ri lale (guardian) ak eo im ej loloorjake men ko mweiien bar juon (executor), court e maroñ kamâlim e bwe en walok ilo court im file e juon legal document ãinwõt inventories im accounting. Bõtab armej eo en kepaak ri ekajet eo me ej bõk eddoon case eo bwe en lale ñe ewor

jet rule ko an court me rej kwalok wōn eo im e maroñ in jerbal āinwōt juon lawyer in court jab in.

Q. Juon eo me e jab lawyer e maroñ ke jojomaare ña ilo makutkut ko an juon case me Court eo e jab loloorjake?

A. Aaet. Ewor jet pepe ko ñan na ruon juon armej me rej jab pād iumwin tōl im pepe an juon court (administrative proceedings), āinwōt Workers Compensation Commission ak Arkansas Employment Security Department, me juon eo im e jab lawyer e maroñ in jojomaare armej ro im rej bōk kunaaer ilo juon proceeding. Kwon baj lale rule ko an kumi eo me ej bōk eddoon proceeding eo im lale elaññe kwōj aikuje juon lukkuun lawyer. Kwon barāinwōt check im lale elaññe ewor jet kakien ko ikijien an juon me e jab lawyer represent e juon armej. Ijoke, juon eo me e jab lawyer e jab maroñ in jojomaar e (represent) yuk ak jabdewōt bar juon armej ak legal entity ñe ej akwelep kōn juon pepe an court. Juon lawyer wōt e maroñ jojomaare yuk ikijien men kein. Elaññe juon eo me ejab lawyer ej file e juon men in akwelep (appeal), Court enaaj kawaan e filing eo, im e ban kile akwelep eo.

Q. I maroñ ke jojomaare juon business ak juon kumi me kien ej kile e (legal entity) ilo juon case in court?

A. Jab. Juon corporation ak legal entity ej aikuj bwe juon lukkuun lawyer en jojomaare er ilo case in Court. Jabdewōt men eo im armej eo me ejab lawyer ej kōmmane ilo etan corporation eo (ak ñan jipañ corporation eo, jojomaare corporation eo) ak jabdewōt legal entity ilo case in court, Court enaaj kajekdoon e, im watōk e juon men me ejjelok tokjan. Āindein meñe juon eo me ejab lawyer ej jojomaare juon legal entity ilo administrative proceeding im ej wanmaanlok im akwelap (appeal) ñan juon Court. Juon lawyer me elōñ an license e aikuj in kōmman peba in akwelap.

Q. Elaññe ejjelok aõ cent bwe in wiaik juon lawyer, I maroñ ke bōk jipañ jān juon lawyer ediklok onean an jerbal, ak ejjelok onean an jerbal.

A. Aaet. Kwon lale www.arlegalservices.org im lale ñe kwōj kain eo me e maroñ in bōk jipañ jān juon lawyer im ejjelok onean (free legal aid). Arkansas ej barāinwōt kōtlok bwe juon lawyer en lewōj kain jipañ eo me ewor joñan an lewōj kapilōk im joñan an jerbal. Āinwōt juon ne kwō kkar ñan ebbōk jipañ jān juon lawyer im ejjelok

onean ak ediklok onean, kwo maroñ ebbōk am melele kōn kajjitōk ko ikijjen “legal” jān <https://ar.freelegalanswers.org>

Q. Ta unin aer kōmmani elōñ kakien me ej dāpiji ak kabwijri jerbal in lawyer?

A. Rule kein me rej lale jerbal in lawyer rej kein kōjparok armej. Bwe en emman an armej tōmak im lōke lawyer ro, ebwe an lap joñan aer training, im en lap kapeel eo aer. Im rej jerbal iumwin juon jemānae e kanooj in lap im pen me ej lale im mālejjoñe mwileir. Ro im re jab bōk aer license bwe ren lawyer ilo Arkansas, re jab pād iumwin jemānae kein, im armej ro jet enaaj pen aer tōmak bwe naan in kapilok ko aer renaaj jimwe im jejjet ekkar ñan kien Arkansas.

Q. Wōn eo ej lale lawyer ro im wāween aer jerbal ilo Arkansas?

A. Arkansas Supreme Court eo wōt ewor an maroñ ñan loloorjake aolep jerbal ko in lawyer.

Q. Wōn ej lale “ro im e jab mālim aer jerbal āinwōt juon lawyer?

A. Meñe Arkansas Supreme Court ewor an maroñ ñan pepe kaki men ko ikijjen an armej jerbal āinwōt juon lawyer meñe ejjelok an license, emōj an court kajutak Supreme Court Committee on the Unauthorized Practice of Law bwe en etale naan in kinaaklok ko ikijjen ro im rej kōmmani jerbal ko an juon lawyer ak ejjelok aer license. Bōtab, committee in ewor joñan aer maroñ ñan liaaklok im kajeik ro im rej jerbal āinwōt juon lawyer ak ejjelok aer license.

Elaññe kwo jab maroñ kepaake juon computer bwe kwon kanōketok e form eo, kwon jouj in call 501-376-0313 bwe kwon bōk juon form in abnōnō im elōñ melele ko jet. Juon abnōnō e ban wanmaanlok ñan ñe juon armej ej kane im lelok form jab in.

Q. Ta eo enaaj walok ñe ij file e juon abnōnō.

A. UPL Committee enaaj lale abnōnō eo, im pepe elaññe ej pād iumwin tōl im pepe an committee eo aer ke jab. [Elaññe abnōnō eo ejab pād iumwin tōl im pepe eo aer, bōtab ej pād iumwin tōl im pepe an bar juon committee, renaaj kajelāik yuk kōn committee eo im e maroñ loloorjake abnōnō eo am]. Elaññe abnōnō eo ej pād iumwin tōl im pepe an committee eo, renaaj kwalok ñan yuk bwe emōj aer lo abnōnō eo am. Im renaaj kwalok tu karoñ wāween aer naaj wōnmaanlok kake. Ri jerbal ro an committee in renaaj lale aolep melele ko ikijjen abnōnō eo am innām lelok ñan committee eo bwe ren vote kake im lale elaññe emman aer wōnmaanlok im etale ke jab.

Elaññe committee eo ej vote bwe ren wōnmaanlok im etale abnōnō eo, ri jerbal ro renaaj jino aer etale im lelok melele ko aer ñan committee eo. Barāinwōt, renaaj jilkinlok abnōnō eo ñan armej eo me kwōj abnōnō kake im kajjitōk bwe en lelok juon uwaak. Ñe emōj an committee lale tōprak in aer etale abnōnō eo, renaaj vote kōn ta eo im ren kōmmane. Melele in, re maroñ lo bwe ejjelok ruon eo im kwaar abnōnō kake, ak remaroñ in lemaanlok ñan juon Court bwe en kabwirak armej eo jān an jerbal āinwōt juon lawyer. Committee eo enaaj kwalok ñan yuk pepe eo aer ilo iien eo e mōkaj tata.
